John Armato, resident of Buena asked why AtlantiCare is the only organization receiving the Opioid settlement money. organizations could aid in prevention instead of just opioid treatment.

Creed Pogue, resident of Estell Manor applauded the Board for not seconding Resolution No. 555 and stated it should never have been on the agenda.

Celeste Fernandez, resident of Galloway appreciates the Board not passing Resolution No. 555 and stated the community needs to work together.

Steven Young, resident of Atlantic City thanked Commissioner Balles for a productive meeting regarding the jail and for the Board not voting on Resolution No. 555.

Jose Rivera Sinclair, resident of Egg Harbor Township thanked the Commissioners for not passing Resolution No. 555. Atlantic County is an open, welcoming place for all.

Naya Lorick, resident of Northfield stated she is an immigrant whose family contributes greatly to the community.

Charles Weisberger, resident of Egg Harbor City is grateful that the resolution was not seconded. He pointed out that immigrants are not illegal or criminals.

Kim O'Brien, resident of Somers Point stated immigration is a federal problem and thanked the Board for not passing the resolution.

Victoria Druding, resident of Egg Harbor Township is pleased the resolution did not move forward and highlighted a Rutgers study on immigrants.

Dominic Sambucci, ACCC Chief Business Officer asked the Board about the status of the transfer of Chapter 12 funds for the baseball field project. A discussion ensued.
