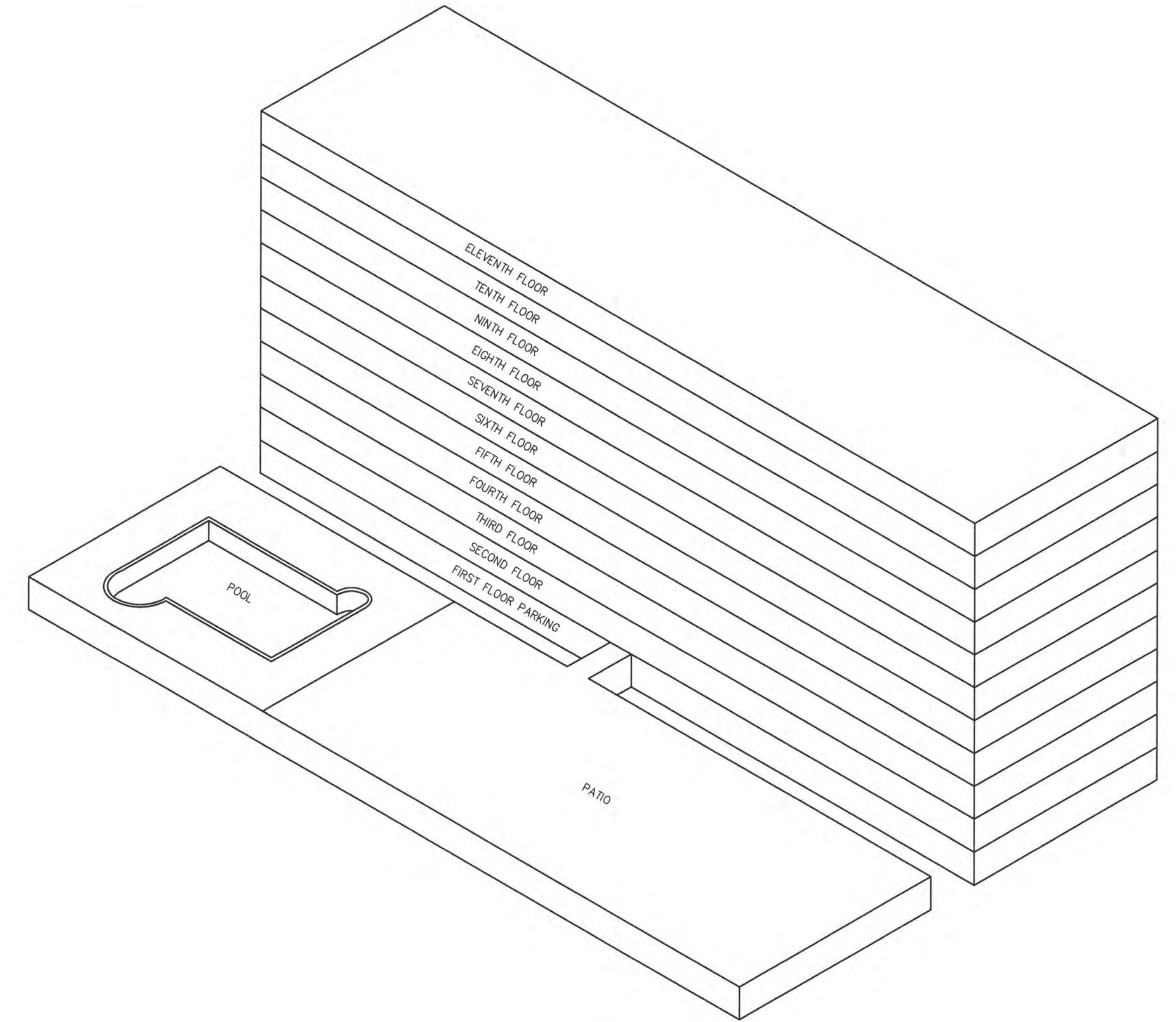
PLAN

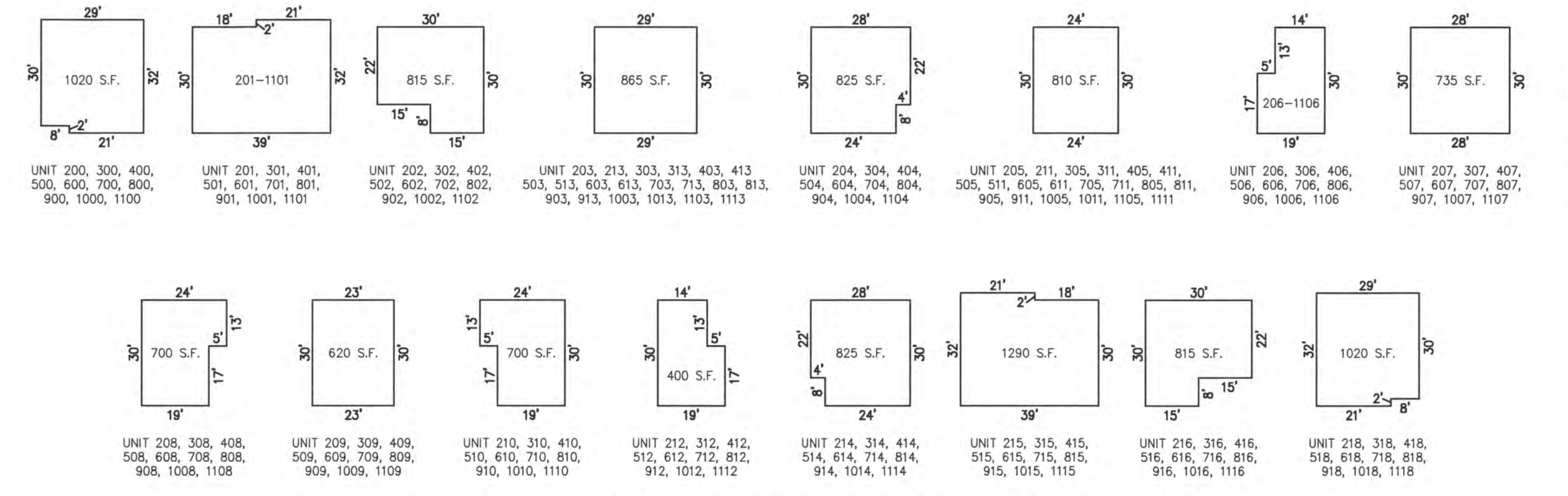
SECOND FLOOR - ELEVENTH FLOOR
