



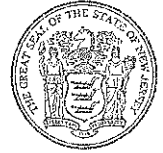

N.J.S.A. 19:61-9: AUDITS OF ELECTION RESULTS

2021 General Election

Audit Date: November 17, 2021

The Atlantic County Board of Elections (BOE herein) performed an audit consistent with the provisions of N.J.S.A. 19:61-9 and the New Jersey Election Audit Procedures developed by the New Jersey State Division of Elections.

The Atlantic County BOE conducted a hand-to-eye count of the voter-verifiable paper records for the General Election for all state offices, as well as county and municipal offices selected by the Secretary of State. The state offices to be audited are that of the Governor, State Senate, and State Assembly. In addition, a municipal wide office must be included such as city council, common council, township committee, etc. As directed by the Division of Elections and Secretary of State Tahesha Way, the Board Commissioners could choose a countywide office and the Commissioners agreed upon County Clerk for the countywide office. All other offices and public questions were excluded from the audit.

Each Legislative District must be audited separately from the next. The County of Atlantic contains 4 such districts, the 1st, 2nd, the 8th and 9th. Pursuant to the statute, "the audit shall be conducted in at least 2% of the election districts." Further, under the guidelines, if a legislative district has fewer than 100 units then at least 2 units must be audited from that district.

The table below indicates which audit units were randomly selected:
