**NEW BUSINESS** Commissioner Fitzpatrick reported that on August 25, 2022 the Atlantic County Criminal Justice Advisory Board hosted a presentation on the use of shooting-response dogs in schools. Commissioner Fitzpatrick stated that there are concerns regarding the proposed canines and handlers in schools and everyone is not in support of this initiative. If the County spends any money on this endeavor, it should come before this Board. A discussion ensued regarding the pros and cons of the program.
