OLDER AMERICANS ACT

- **OAA was Signed into Law by President Lyndon B. Johnson on July 14, 1965**
- **Part of LBJ's Great Society – Agenda which included Medicare, Medicaid.**
- **LBJ said: “The Older Americans Act clearly affirms our Nation’s sense of responsibility toward the well-being of all of our older citizens. But even more, the results of this act will help us to expand our opportunities for enriching the lives of our citizens in this country now and in the years to come.”**

OAA Structure

The OAA set up a framework for partnership among levels of government and the public and private sectors with a common goal to improve the quality of life for older Americans. Over the years, this system has continued to evolve and has grown & been strengthened

Eligibility

- **Age based for those age 60 and over.**
- **Service targeted to those in the greatest social & economic need with particular attention to minority, low income, frail & vulnerable.**
- **Not fee based but a suggested donation is requested.**
- **Targeting provides flexibility over means tested programs.**

OAA Title III Grants for States & Community Programs **on Aging**

- **The largest program under the OAA**
- **Lays out responsibilities for State Units & Area Agencies on Aging.**
- **Provides funding for most services**
- **Has most of the legislative detail**

STATE UNITS ON AGING (SUA)

- **Plan, develop, coordinate and arrange for services at local level.**
- **Divide State into Planning & Service Areas (PSAs)**
- **NJ's SUA - Division of Aging Services. There are 56 State Units on Aging and 629 Area Agencies on Aging**

SUAs CONT.

- **Oversee the AAA**
- **Funds are distributed based on funding formula – total older population & poverty population.**
- **In NJ there is an AAA in each of the 21 Counties.**

Area Agencies on Aging (AAAs)

- **Prepare, develop and carry out and administer an Area Plan Contract (APC) on Aging approved by SUA.**
- **Lead County Agency on Aging - Central Source of information.**
- **Visible focal point for advocacy, coordination, monitoring and evaluation of programs for older people.**
- **Increase the public's awareness and understanding of the Aging process-provide current knowledge.**

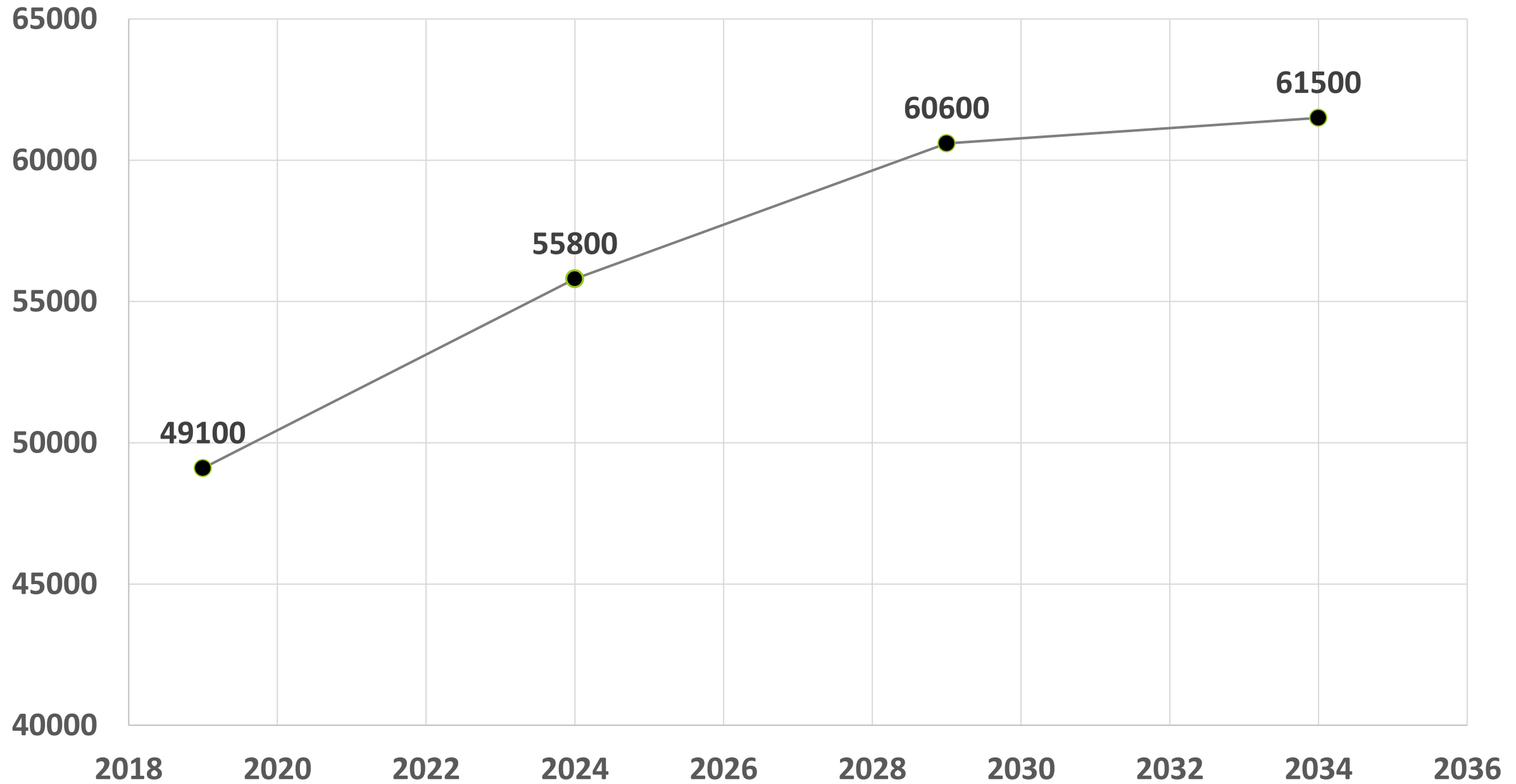
Atlantic County AAA Mission Statement

FACTS

- **Over the next 20 years the proportion of the U.S. population over age 60 will dramatically increase, as 77 million baby boomers reach traditional retirement age. By 2030 - in just 9 years- more than 70 million Americans will be 65 and older, twice the number in 2000 and more than 4 times the number in 1963 (17 million). At that point, older Americans will comprise nearly 20 percent of the U.S. population, representing 1 in every 5 Americans.**

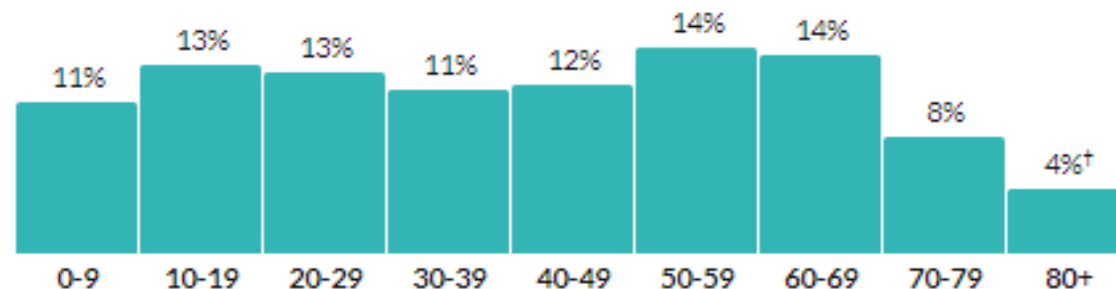

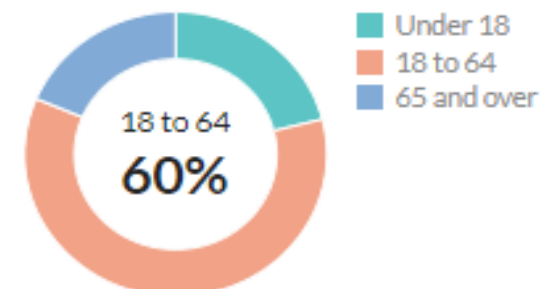
