County 97, Parks, of the Code of the County of Atlantic



All pavilion rentals are available between 7:30AM and Sunset.

Shelter at McClinton Park (OEM) (201 New Hampshire Road, Atlantic City, NJ, 08401)	\$35.00/event
A central pavilion provides scenic views of the Absecon Inlet. This waterfront park includes a children's play area. Ideal for weddings and picnicking. Limit 100 people	
Gazebo in Gaskill Park (40 Farragut Ave, next to Mays Landing Library, across from bulkhead)	\$35.00/event
This beautiful park is located across from the bulkhead of the Great Egg Harbor River in Mays Landing. This park also provides a scenic view for photography, and is a popular spot for weddings. Limit 100 people.	
Pavilions in Estell Manor (109 State Hwy 50, Mays Landing, 08330) (GPS: Fox Nature Center)	\$35.00/event
Estell Manor Park is a 1700 acre park located 3.5 miles south of Mays Landing on Route 50. This is Atlantic County Park System's most popular park. Pavilions A&B both have electric, not C. Limit 50 people per each pavilion.	
Gazebo in Lake Lenape Park West (6303 Old Harding Hwy, Mays Landing, 08330)	\$35.00/event
The gazebo is located near the playground with a lake view. Ideal for birthday and wedding parties. Great place for fishing or boating on the lake. Limit 50 people in surrounding area. (*GPS address is 6126 Old Harding Highway)	
Lake Lenape Park East (753 Park Rd: Behind Young's Skating Center)	
Lake Lenape East has been completely renovated with new walkways, new pavilions and a Catering Hall overlooking the lake. This park also has a baseball field and 1 volleyball court for your enjoyment.	
<i>Pavilion 1&2 (Limit 100 people) has electric and water</i>	\$65.00/event
<i>Pavilion 3 (Limit 50 people) has electric</i>	\$35.00/event

Individual/Family Tent Campsite (Sites 1-18)	\$17.00/night
Lake Lenape has 18 individual campsites available. You may use a tent or pop-up at these sites. Each site has a picnic table and fire bin. These sites are carry-in/carry-out. Trash and recycling can be placed in the main dumpster located at the campground entrance. There is a maximum of 2 cars per site and 6 people per site.	
Individual/Family Tent-Primitive Campsite (Sites 20-22,24,28,30-35)	\$17.00/night
There are 11 brand new individual primitive campsites at Lake Lenape. There is a main parking area campers will utilize. These sites are carry-in/carry-out. Trash and recycling can be placed in the main dumpster located at the campground entrance. Each site has a picnic table and a fire bin. There is a new bathhouse campers may use that has bathrooms and showers. Maximum 4 people per site.	
Individual/Family Lean-To Campsite (Sites 19,23,25-27,28)	\$17.00/night
Lake Lenape has 6 brand new 3-sided lean-tos. There is a main parking area campers will utilize. These sites are carry-in/carry-out. Trash and recycling can be placed in the main dumpster located at the campground entrance. Each site has a picnic table, fire bin and lean-to. There is a new bathhouse campers may use that has bathrooms and showers. Maximum 4 people per site.	
Group Tent Campsite	\$25.00/night
There are (2) group campsites at Camp Acagisca , (Sites 1 and 3.) Group sites are designed for larger camping groups. There is also (1) group campsite located at the North End of Estell Manor Park , (Site 1.) Maximum 20 people.	
Acagisca Lodge (6755 Weymouth Rd/ Route 559, Mays Landing, NJ 08330)	
The Lodge at Camp Acagisca was refurbished in 2009. The Lodge is mainly used for meetings, parties and gatherings. Only 1 group can reserve the Lodge/Campsite 1 area at a given time. Overnight sleep in the Lodge is prohibited. Available 8:00 a.m. - ½ hour after sunset. 50 person maximum. (tables, chairs, microwave, bathrooms, no a/c)
