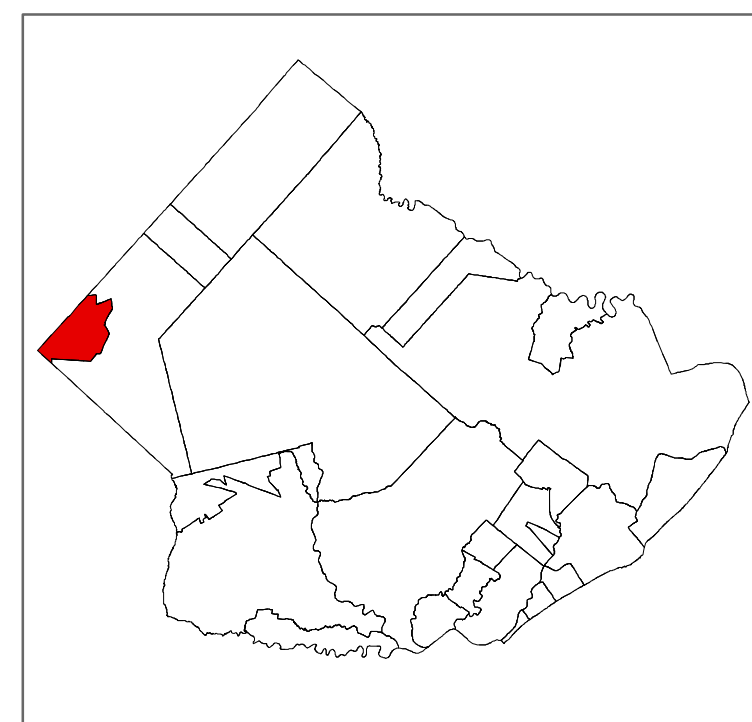
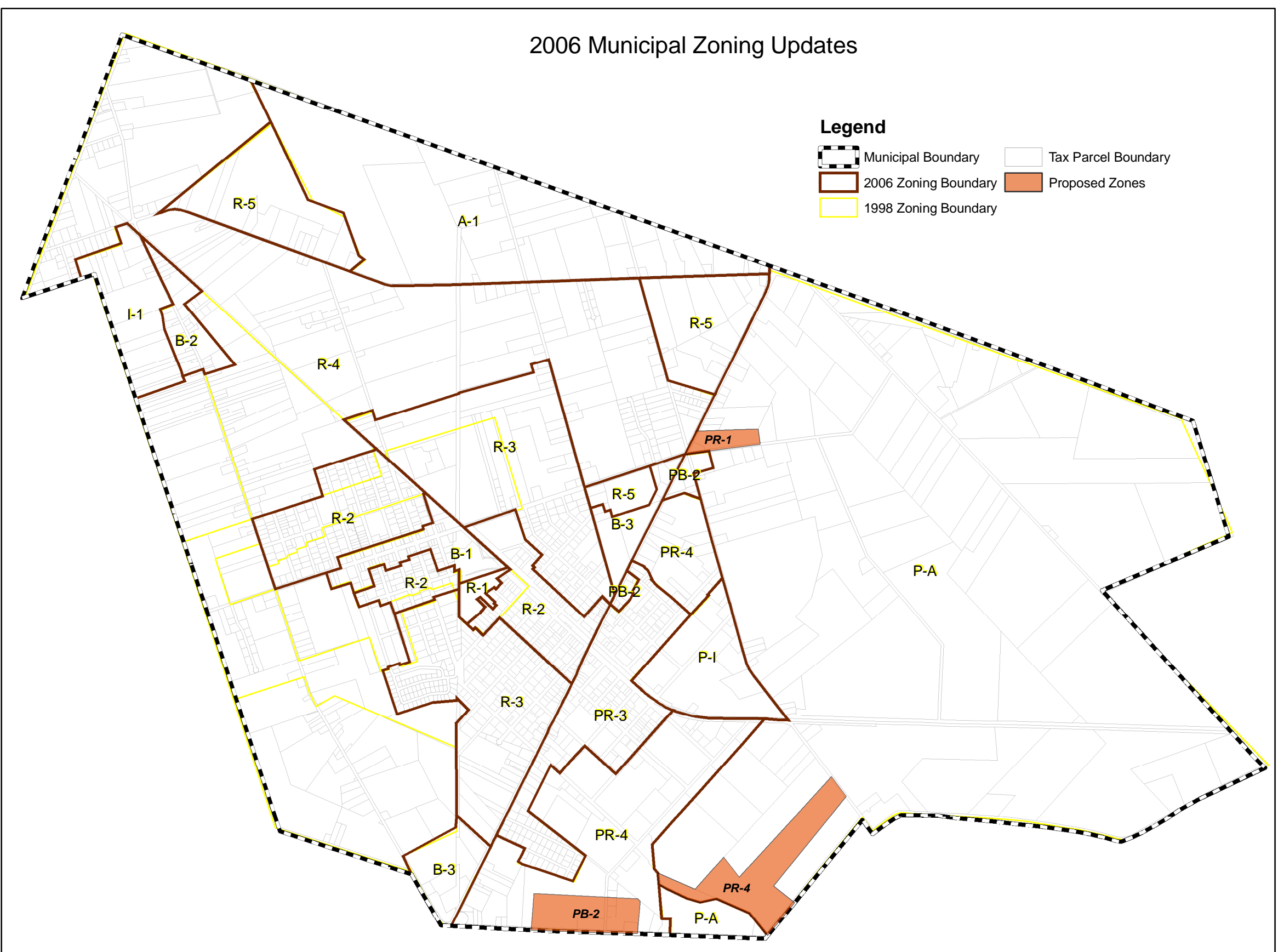


Buena Borough Municipal Zoning Boundaries Atlantic County, NJ
